Terms and Conditions of Sale and Delivery

1. Shipping: Shipments are made at the customer's expense and risk, freight prepaid to a German destination. Additional express charges and postage fees are borne by the buyer. The choice of shipping method is at our discretion. **2. Delivery Times:** Delivery times are non-binding and subject to prior sale. They are calculated based on order confirmation and receipt of all required documentation. Adherence to delivery times, which are approximate unless otherwise agreed upon, is contingent upon unforeseen circumstances in production or other hindrances, such as force majeure, transport delays, or operational disruptions at the supplier's facilities. **3. Prices:** Invoicing is based on the prices and discounts applicable on the date of delivery. **4. Payment:** Invoices are payable within 30 days of the invoice date without deduction or within 14 days with a 2% discount. The discount does not apply if the buyer has outstanding payments. In case of delayed payments, we will charge default interest at the prevailing bank interest rates. **5. Retention of Title:** The delivered goods remain our property until full payment has been received, i.e., until the complete account balance is settled. Any pledges or third-party claims affecting our property must be reported to us immediately. In the case of resale, the buyer must agree on the same retention of title with their purchaser. Upon request, the buyers must notify their customers accordingly without delay. Should our goods become an integral part of a primary product through combination with other items, it is agreed that co-ownership in proportion to § 947 (1) BGB will be transferred to us, and the buyer will store the product on our behalf. Otherwise, the provisions of the first paragraph apply correspondingly. **6. Complaints:** Complaints regarding the quantity, quality, or inadequate packaging of the shipment can only be made within 8 days of receipt of the goods. For justified and acknowledged complaints, we reserve the right to provide replacements or issue credit notes; any other claims for compensation are excluded. We do not accept liability for consequential damages. For parts requiring custom manufacturing, complaints about minor deviations in quantity are not accepted, provided they are within reasonable limits. **7. Place of Fulfillment and Jurisdiction:** The place of fulfillment for delivery and payment, as well as the court of jurisdiction, is Velbert.
